PROJECT ACTIVITIES

Batak IP's Relief Assistance After Typhoon Odette

At the end of 2021 Typhoon Odette destroyed the Batak villages in Cleopatra's Needle Forest Reserve. We supported our former staff Arvee Salazar financially with the relief assistance to the Batak communities. Relief was provided in 3 phases.



December 26, 2021:

The military provided assistance to deliver the goods. The following good were provided to the communities of Manggapin, Tagnaya, and Kalakwasan communities: 90 pcs blankets, 60 sets plates, 60 sets cups, 60 pcs kaldero, 4 kls salt, 90 bars detergent soap, 270 kls nails, 25 backpacks.

For Langogan residents at the evacuation center the following goods were provided: 50 kls squash, 5 kls bottle gourd, 5 kls taro, 6 kls salt, 120 pcs sardines, 15 sets plates, 15 sets cups, 1 box assorted goods (soaps, coffee, noodles), 1 bag clothes and blankets.







January 1, 2022: More goods were provided. Areas of concentration were the 4 sitios of Brgy. Langogan, IP and non-IPs, where all families have lost their homes including basic tools and kitchen utensils.









January 5, 2022: Our last scheduled relief operation, 21days after the typhoon. Targeting the remaining households in Brgy Langogan who have requested for kitchen utensils during assessment. Kitchen utensils their family and family members can use to be able to cook food on their own and eat properly, while still staying at the evacuation centers. We have also supported them with food supplies.







Philippine Taxonomy Initiative

In 2021 the PTI carried out the 1-year study "Taxonomic Study of Selected Plants in the Forests of Pantabangan-Carranglan Watershed Forest Reserve (PCWFR), Nueva Ecija, Philippines". The study generally aims to establish a floristic listing of flowering plants in PCWFR. Three new species were found: *Amorphophallus minimus, Ardisia kalimbahin*, and *Begonia naemma*, among many other species in other areas in the Philippines. Fins and Leaves is an annual donor of PTI. We also assist with proposal writing for new projects on reforestation.





Mentoring Harvard student

In October 2022, we mentored Chelsea Xia, a student at Harvard College studying Bioengineering and Environmental Sciences & Public Policy. As part of her course "Contemporary Developing Countries: Entrepreneurial Solutions to Intractable Problems" that aims to promote entrepreneurship as a force for social change, she needed to create a business plan to help solve an "intractable problem" of their choice. Past ventures born from this class have gone on to win pitch competitions, obtain funding, and actually come to life. We supported Chelsea and her team with their idea on sustainable seaweed aquaculture in the Philippines.
